Thank you very much for your interest in obtaining psychiatric care from Dr. Dorsey and his colleagues at Moundville Medical Associates (part of the Hale County Hospital System). To help set you up for success and a positive experience, we want to share our approach to care to make sure it matches your expectations. Each provider has a different approach to care and it is not setting you up for success when our approach differs from your expectations. To help avoid this, please read the following carefully before scheduling your appointment with us. If our approach is not what you are looking for, we encourage you to seek out care with another provider who will be a better match for your expectations. Thank you.

## **Controlled Substances\***

\*Controlled substances include STIMULANTS such as Adderall (amphetamine/dextroamphetamine), Ritalin (methylphenidate), and Vyvanse (lisdexamfetamine) and BENZODIAZEPINES such as Ativan (lorazepam), Xanax (alprazolam), Klonopin (clonazepam), Valium (diazepam), and Ambien (zolpidem).

Dr. Dorsey steers strongly away from and does not routinely prescribe controlled substances for
patients. Instead, our approach with patients is to focus on appropriate non-controlled
substance medications in combination with behavioral interventions. When patients actively
invest in this approach, most see at least significant partial improvement of symptoms. From a
behavioral standpoint, we tend to focus on helping patients move towards healthier behaviors
such as exercise and physical activity, diet/decreased caffeine consumption/decreased sugar
consumption, healthy relationships, healthy sleep patterns, healthy management of screentime,
and other healthy habits.

## **Team Approach to Care**

• Dr. Dorsey sees all new patients for an initial evaluation. In most cases, after the initial evaluation with Dr. Dorsey, your care will transition either to Dr. Dorsey's nurse practitioner (April Tucker) or to Dr. Rachel Rackard who is a family medicine physician at Moundville Medical Associates who has experience and background in mental health. Dr. Dorsey is available to April and to Dr. Rackard for consultation in your ongoing care. If needed, you can always be referred back to Dr. Dorsey for additional follow up.
